This means that when duplicate calendars within an entity would otherwise result in one of them not being extracted, having different track numbers will allow both to be created. Also, for entities using the PEIMS Entity field, including the track will mean that calendars that have identical start and end dates (where only the calendar in the reportable entity should be reported) will now result in only one of the calendars being reported if their track numbers are the same. Conversely, if the dates match, but both calendars need to be reported anyways, as when there are different attendance minutes to be reported, then both calendars will be extracted if the track numbers are different. And, in all cases, CalendarDate records will continue to be created for every calendar that has had ReportingPeriod records created for it.
- 2 Texas Users: PEIMS processes have been updated for handling teacher transactions outside of Course Length Sets. 305 Records will now assign the correct teacher if the teacher dropped outside of when the class was taught.
