1 - Texas Users: The Build PEIMS Class ID option has been made available for all districts. This option will change how the Class ID element is created by using an alternate method based on the internal identifier for a course. This option was created to allow districts with Course Keys greater than six characters in length to be able to generate the Class ID for PEIMS reporting while still maintaining each ID's unique nature. There are several items districts should be aware of prior to enabling this option:
1. While the default method uses a combination of several elements

to produce the ID, the alternate method uses only two, the internal course identifier and the section. This means that the resulting ID contains very little information to help a user identify the class that generated it, unlike the default method. This can make troubleshooting issues more difficult.

2. If the option is enabled after data for PEIMS Submission 1 has been accepted by the state, the Class IDs generated for Submission 3 will be different than those that were reported in Submission 1.
