

These release notes are organized into groupings, based on the menu path of the project.

The first level is Federal reporting, State reporting (or related), or General Updates. Within those groupings, notes are divided between Systemwide, Business Systems, and Student Systems. Within those areas, they are divided into module groups (menu paths with similar data areas), then sorted by menu path.

For ease of viewing, and utilization of bookmarks, we recommend that you download and save this file, and open it locally with your PDF viewer, as some browsers may not support viewing of bookmarks (Chrome). In Firefox, you can access the bookmarks by clicking on the Toggle Sidebar icon in the upper left corner of the reading pane.

Once downloaded, to navigate, you should be able to use your pdf reader's bookmarks in the left slider bar. By clicking on the bookmark icon, the bookmarks will display. The actual display may vary depending on your pdf viewer and version.



You can expand an area by clicking on the "+", collapse it by clicking on the "-" to the left of the heading. You can use the slider bar in the bookmark window to navigate and select any section to view it. Depending on your pdf reader, you may be able to select the area, right mouse click, and print that section in one action.
